

The project is for the installation of play equipment at Whitehouse Park in Whitehouse. The land is owned by The Parks Trust and Whitehouse Community Council has worked with the Trust on the type of equipment that would be suitable for the area and which covers the requirements of the Council and residents.

Installation of 4 pieces of toddler play equipent at Whitehouse Park:

Playhouse with safety panels = \pounds 5,505 Greta Slide = \pounds 6,545 Toddler Flower Swing (ages 2-5) (single) = \pounds 1,925 Toddler Little Comic Swing (ages 0-3) (single) = \pounds 1,755 10% Equipment Contingency: = \pounds 1,573 Surfacing Costs: \pounds 500

There is a 10% contingency on equipment costs due to rising cost.

The advice at the moment is that there are delays in sourcing play equipment for various global situational issues.

Ordering early in 2023/2024 estimated installation would be around May/June 2023. If there are any further delays, then installation may be need to be postponed until September 2023 as equipment will not be installed over any school holiday due to the the level of disruption at a time when existing play area use is at its peak.

Whitehouse Community Council has committee 50% of the project cost in its 2023/2024 budget.

The area of land is located in between a play area for older children and a Multi-Use Games Area.

Expected outcomes

The additional play equipment will benefit young children and families with small children. It would also benefit families that are made up of young and older children. Placing the toddler play equipment close play facilities for older children could result in more whole families having the opportunity to play together.

There is a lack of toddler play equipment in Whitehouse and this was highlighted in a recent survey the Community Council carried out to assess the level of satisfaction with existing play facilities in the area. The area is next to development land and there are no plans for a play area to be installed in that location.

The proposed facility would provide for much needed toddler play equipment in the area.

What are the consequences of not doing this proposal? Will there be an impact on the community? Will it make an existing issue worse? (Give brief details)

Whitehouse is a development area based in the Westerna Expansion Area. The survey carried out by the Community Council indicated that there was a lack of toddler play equipment in the area. This situation will worsen as the area expands.
